TOURNAMENT SCHEDULE 2002:

The State Tournament scheduled for Friday, Saturday and Sunday, September 6, 7 and 8 at Casa Blanca was discussed. It was decided that changing dates was not an option. Mindy Zamzow called Ruby View Golf Course in Elko as a possibility but they were unable to accommodate us. Laurie will continue to research other possibilities.
